

Nonexclusive License to Electronically Disseminate Faculty Scholarship

University Libraries at the University of Louisville ("UofL") and you as *Author and acting on behalf of any and all co-authors of a multi-author Work* ("you" ("your")) wish to enter into a nonexclusive license in order to preserve and disseminate worldwide through the internet and/or any other publicly accessible and/or secure digital networks your scholarly Work ("the Work") described more fully in the deposit instructions and your submission file incorporated by reference herein.

A nonexclusive license in no way limits you as the copyright holder to the extent that you have not otherwise assigned your rights in making other nonexclusive uses of the Work. You otherwise retain all rights in the Work subject to the nonexclusive grants and conditions of this license and U.S. copyright law and accordingly hold sole responsibility along with any and all co-authors for complying with copyright and other legal requirements that govern the ownership and enforcement rights of Authors. This nonexclusive arrangement allows UofL to make the Work accessible through any technologies and formats but otherwise authorizes no material changes in substantive content.

To that end:

1. You grant to UofL and its agents nonexclusive, irrevocable, and worldwide rights and license to reproduce, and distribute, to prepare collectives, compilations, and structural derivatives, to publicly or otherwise perform and display, and to modify the Work's format and/or display characteristics consistent with this license and the requirements of applicable technologies (for example: software upgrades, platform revisions, migration needs, or other changes) as determined by UofL at its sole discretion. Such changes would not ordinarily alter substantive content but would solely reshape its formatting in support of long-term viability and preservation. You also acknowledge and agree that this nonexclusive license and the terms and conditions will govern this specific deposit and all other deposits of your scholarship into the UofL institutional repository whether deposited on one or separate occasions and whether deposited by you or by an administrator of the UofL institutional repository acting on your behalf.
2. You represent and warrant that you have full authority on behalf of yourself and any co-authors of a multi-author Work to enter into this license as sole and/or joint rights holder and/or contractually through a pre-existing publication and/or other agreement. You also represent and warrant that you and/or any co-authors have not included in the Work any audio, video, programming, textual material, information, and/or other content and/or data that (1) defames a third party, (2) violates any existing agreement between you and another party, including confidentiality agreements, or (3) infringes any intellectual property rights, including copyright, patent, trademark, trade secret or other rights of a third party, (4) and otherwise complies with all applicable laws. You also represent and warrant on behalf of yourself and any co-authors that you have included any copyrighted materials in the Work solely with written permission of the rights holder or in compliance with a "reasonable and good faith" application of fair use as articulated in 17 U.S.C. §107 of United States copyright law and that you otherwise have also complied with applicable funder and/or grant conditions and requirements including any mandated open access conditions and specifically identified any U.S. government authors or co-authors who produced the scholarship in the course of their U.S. government duties.
3. Administrators of the UofL institutional repository may from time to time need to contact publishers and/or communicate on your behalf with other individuals or rights holders regarding your publications and their copyright status, including discussing the terms and conditions of the agreement and whether the publisher will waive any specific conditions necessary to permit depositing your scholarship in the UofL institutional repository. You agree that UofL may act on your behalf in this and similar ways in order to mediate the deposit of your scholarly content into the UofL institutional repository on your behalf and make it available worldwide. You agree to hold UofL harmless and to indemnify UofL for reasonable attorney fees, costs, and damages in the event of a claim or allegation arising from or relating to the Work and/or your deposit

of it in the repository including for any claims arising as a result of UofL acting on your behalf in order to secure, clear, and/or assess any rights necessary to effect the deposit.

4. You as Author acknowledge and agree on behalf of yourself and any and all co-authors that UofL may remove or otherwise disable the Work under the force of law, for allegations of infringement or other occurrences, or due to circumstances beyond UofL control and that UofL makes no warranties whatsoever regarding the repository or whether the Work will be included in it. UofL will exercise sole discretion in determining when and/or whether to make the work available and/or remove or disable access to the Work.
5. You also affirm and agree that you have not included any attachments and/or appendices in the deposit and/or the Work that conflict with or otherwise attempt to modify this agreement and agree that any such attachments or appendices if included would have no force in interpreting or enforcing this agreement.
6. You further affirm that this document meets the accessibility requirements of ADA Title II.
